Deploy fast

The solution is delivered in a SaaS model and is hosted on multiple clouds as per territorial regulations. For large enterprises and governmental bodies, the solution can also be delivered on premises.



Protect employees

The employee app works in the background and privately records all proximity and contact events on the employee personal device. The app also provides a reminder to fill out the health statement upon entering the facilities every morning. As an added value, Shield for Business allows adding location-based engagement features.



Shield visitors

When entering the company facilities, visitors can check in using a QR code, NFC tag, or URL. Upon check-in, the visitor is required to comply with the organization's health policy. Companies may require visitors to check in in other spots within the facilities to document their "trail" for later proximity analytics.

How it works


Once employees have tested positive for Covid-19, they may voluntarily share their timeline to assist the organization and its community in quickly breaking the chain of infection. The anonymous location timeline is compared with relevant employee and visitor timelines. If a potential exposure is identified and a user has been close enough to a confirmed case of Covid-19 for at least 15 minutes, the user is alerted. Employees who have been exposed to Covid-19 can confirm the alert or comment on it and receive instructions for self-quarantine. Additionally, the facility manager receives anonymous indications of microlocations that might require disinfection.





Discreetly Manage and Monitor

Provide health coordinators with an effective management dashboard for discreet monitoring and control



- Review cases and exposures within the organization
- Be alerted of contaminated locations in need of disinfection
- Receive online alerts of crowd density violations
- Get indications of employees or visitors who did not self-report
